MC or LUP: Map Clearance or Land Use Permit (fee payable prior to map recordation or Land Use Permit if no map recordation)
- Quimby Fee for Lompoc area is **\$3,610**.

- Transportation impact fees vary by region throughout the County. Outside of the Goleta and Orcutt Planning Areas, fees are determined based on the number of peak hour traffic trips (PHT) generated by the project. In the Santa Barbara, Montecito, Summerland, Carpinteria and South County areas, the fee is **\$2,258** per PHT, and **\$1,173** per unit for Residential Second Units. For all other unincorporated areas of the County, the fee is **\$607** per PHT, and **\$315** per unit for Residential Second Units. A PHT is equivalent to a single family dwelling. Contact Public Works Transportation staff (805-739-8785) for estimate of PHT.
- Fire charges **\$940/1,000 sf** for Office, **\$710/1,000 sf** for Industrial, **\$520/1,000 sf** for Warehouse/Distribution, and **\$350/1,000 sf** for Agricultural buildings.
